1 WELCOME AND APOLOGIES

Paul von der Heyde welcomed everyone to the inaugural meeting of the NHS Somerset Integrated Care Board (ICB) (NHS Somerset). Apologies were received from those listed above.

Paul von der Heyde invited Members to introduce themselves, and outlined his ambition and determination for the ICB to build upon and develop the work of Somerset CCG, the ICB's predecessor organisation; and to increase cross-

system working to ultimately improve the health, care and wellbeing of the Somerset population.

Challenges include:

- pressures in emergency departments
- increasing demand for mental health services
- demands on primary care
- patient flow through the acute hospitals
- upcoming Winter pressures
- NHS 111
- population expectation
- financial expectations

NHS Somerset is not a hierarchical organisation: rather, we will address the challenges through honest, open and constructive dialogue, sharing ownership of the difficulties, and working together to deliver solutions.

2 REGISTER OF MEMBERS' INTERESTS

2.1 The ICB Board received the Register of Members' Interests relevant to its membership, noting that some members are still to register on the database.

3 DECLARATIONS OF INTEREST RELATING TO ITEMS ON THE AGENDA

- 3.1 Under the ICB's arrangements for managing conflicts of interest, any member making a declaration of interest can participate in the discussion of the particular agenda item concerned, where appropriate, but is excluded from the decision-making and voting process if a vote is required. In these circumstances, there must be confirmation that the meeting remains quorate in order for voting to proceed. If a conflict of interest is declared by the Chairman, the agenda item in question would be chaired by the Deputy Chair.
- 3.2 There were no declarations of Interest relating to items on the agenda. The quoracy of the meeting was confirmed.

4 ICB ESTABLISHMENT APPOINTMENTS

- 4.1 The meeting received and noted the ICB establishment appointments of Paul von der Heyde as Chair, and Jonathan Higman as Chief Executive, as authorised by NHS England.
- 4.2 The meeting noted the agreed composition of the NHS Somerset Integrated Care Board (ICB) (NHS Somerset).
- 4.3 The meeting noted that Paul von der Heyde will be the founder member of the Integrated Care Partnership (ICP), which is a statutory committee established jointly between the ICB and the Local Authority.

4.4 The meeting noted the summary of special roles and responsibilities that had been assigned to the various executive and Non-Executive Directors

5 NHS SOMERSET ICB CONSTITUTION

- 5.1 The meeting received and noted the NHS Somerset Integrated Care Board Constitution, as approved by NHS England.
- 5.2 The Establishment Order of the ICB has been issued by Elizabeth O'Mahony.
- 5.3 The ICB Constitution will be reviewed after 12 months.
 - Action 002: ICB Constitution to be added to the business planning cycle for June/July 2023 (Jade Renville)
- National discussions are taking place regarding the potential inclusion of the Local Medical Committee (LMC) Chair as an observer on ICB Boards.

 Currently, the LMC Chair is a member of the Primary Care and Direct Commissioning Committee, and also of the People Board.
- 5.5 Members of the public are welcome to observe ICB Board meetings in public. The Chair of Healthwatch Somerset is a participant on the Board, and we are looking to strengthen our engagement function to ensure that the voice of the public is strong in guiding our priorities and holding us to account.

6 GOVERNANCE HANDBOOK

- 6.1 The meeting received a suite of key statutory documents comprising the Governance Handbook, including the proposed Terms of Reference (ToRs) for the various ICB committees.
- The ToRs are a blend of the NHS England model ToRs and the former CCG committee ToRs. As a priority, they will be taken to the respective ICB committees for discussion and development, together with the inherited action logs. Each Chair will bring recommended changes to their Committee's Terms of Reference to the ICB Board.
 - Action 003: Following discussion by their Committee, bring any recommended changes to the Committee ToRs to the ICB Board (Committee Chairs)
- 6.3 Referring to the Remuneration Committee ToRs, it was agreed that the following sentence be removed, as it was included in error: "The Chair of the Audit Committee may not be a member of the Remuneration Committee."
 - Action 004: Remuneration Committee ToRs to be amended (Peter Osborne)
- 6.4 Jonathan Higman advised that the Readiness to Operate Statement (ROS) requires a formal governance review of NHS Somerset within 12 months. All documents contained within the Governance Handbook have been signed-off by NHS England. Referring to the Functions and Decisions Map, committee structures, and ICS system groups, it will be necessary to consider and

streamline the priorities, to ensure the ICB works collaboratively and supportively. We will also need to consider the localities and how solutions are delivered through the Primary Care Networks

- Action 005: Formal governance review of NHS Somerset to be included on the business planning cycle for May/June 2023 (Jade Renville)
- 6.5 Referring to the ToRs for the Primary Care and Direct Commissioning Committee, Trudi Grant suggested that a second Council post should be included on the membership (section 8 refers).
 - Action 006: PCDCC ToRs to be reviewed against the Constitution for the second Council post (Peter Osborne)
- The Board approved the Governance Handbook, recognising it is a work in progress and will be developed.

7 ANY OTHER BUSINESS

- 7.1 Jonathan Higman advised that future meetings will be balanced between formality and Board development. Mel Lock suggested that the social care reform agenda be included as a development activity. Dr Berge Balian also suggested the inclusion of primary care, given the ongoing challenges of demand, capacity, the impact of Covid etc.
 - Action 007: Social Care Reform, and Primary Care, to be included on the agendas for future development sessions (Jonathan Higman/Jade Renville)
