## **CHIEF EXECUTIVE'S REPORT**

### **1 INTRODUCTION**

- 1.1 This report provides a summary of items of note arising during the period to 23 July 2020 and information on my activity during this period.

### **2 NATIONAL**

#### **Coronavirus Pandemic**

- 2.1 The coronavirus remains a National Level 4 Critical Incident despite numbers remaining relatively low in Somerset and dropping across the country. The separate paper in the Governing Body papers addresses the details.
- 2.2 We are awaiting a Phase III letter to highlight the key issues to be addressed for the remainder of the year through to 31 March 2021. Income for Month 5 (August) will be dealt with in the same manner as Months 1-4.

### **3 LOCAL**

#### **Integrated Care System (ICS)**

- 3.1 The Somerset Shadow ICS Execs group continue to meet to develop our Somerset plan for Phase III and are developing governance arrangements for the proposed full ICS.
- 3.2 The Regional Team has confirmed that the next potential authorisation date for the Somerset system will be November 2020. We are working towards this as a date and I will keep the Governing Body updated of progress.

#### **CCG Staff Colleagues**

- 3.3 The separate COVID-19 paper address our considerable thanks to health and care colleagues across Somerset, along with key workers, volunteers and indeed the wider population, for the way that have responded to the extraordinary circumstances we have been in for the last five months. I would also like to take this opportunity to thank CCG staff colleagues for the manner in which they have responded – to a person they have focused on our twin aims of keeping the people of Somerset as safe as we can and keeping health and care colleagues as safe as we can.
- 3.4 We are looking at how we might recognise this significant support from colleagues across the CCG but to start this off, the July Team Briefing session was turned over to a “Team Special” where we had 14 teams from across our CCG present the steps they had taken to keep the system

- 3.5 running smoothly from finance to frontline care. This was a great celebration of the range of work the CCG undertakes as well as highlighting many of the challenges colleagues are facing, often juggling work commitments against home schooling and care duties.
- 3.6 We will look to build upon the new ways of working as we consider how we plan for the future as well as identifying areas of challenge to address.
